## **SURGE-RELATED TRAVEL QUARANTINE ORDER – PUBLIC HEALTH EMERGENCY ORDER C19-17**

Good Afternoon,

On December 16, 2020, the City and County of San Francisco Department of Public Health issued a Surge-Related Travel Quarantine Order (No. C19-17 - “Travel Order”), **which took effect on 12:01 a.m. on December 18, 2020**, and will remain in effect until 12:01 a.m. on January 4, 2021, but may be extended by order of the Health Officer if the surge continues. Per the Surge-Related Travel Quarantine Order No. C19-17 “Travel Order”:

- A mandatory Quarantine is imposed on anyone traveling, moving, or returning to San Francisco County from anywhere outside the 9-county Bay Area and Santa Cruz County, with limited exceptions described in the Travel Order. The Travel Order also strongly urges a Quarantine for all non-essential travel to San Francisco County from anywhere in the Bay Area outside San Francisco County.
- “Quarantine” means to stay at home or another place of temporary shelter at all times without contact with any person other than members of one’s Household for 10 days (240 hours) from a person’s time of arrival in the County and otherwise in accordance with applicable guidance found at [www.sf.gov/file/after-your-covid-19-test-booklet](http://www.sf.gov/file/after-your-covid-19-test-booklet). - People in San Francisco County are strongly urged to avoid travel whenever possible. When travel is unavoidable, people are strongly urged to follow these best practices:
  - When travelling and after returning, always wear a Face Covering when around anyone who is not part of your Household, including while indoors, in vehicles or other enclosed spaces, and when outdoors within six feet of others.
  - When travelling and after returning, minimize time spent around people who are not part of your Household when any of those people (or yourself) are not wearing a Face Covering, including during meals.
  - When traveling and after returning, minimize interactions with others, such as by avoiding unnecessary shopping, indoor social events, and other interactions in large groups.
- All people in San Francisco County, including those who travel, move, or return to the County from any distance and for any purpose (whether or not exempt from Quarantine under the Travel Order), must comply with the existing Health Officer directives regarding isolation and quarantine.
- All businesses and governmental entities must continue to require that all personnel immediately alert the business or governmental entity if they test positive for COVID-19 and were present in the workplace within the 48 hours before onset of symptoms or within 48 hours of the date on which they were tested.
- All businesses and governmental entities must continue to report to the San Francisco Department of Public Health when three or more personnel test positive for the virus that causes COVID-19 within a two-week period.

- Order No. C19-17 does not affect Order No C19-12c (requiring face coverings), which will continue indefinitely until otherwise directed by the Health Officer. Essential Businesses and entities with workers engaged in Essential Infrastructure Work, Minimum Basic Operations, or Essential Governmental Functions who continue to operate at BAMC must require their employees and contractors to continue to wear a Face Covering in accordance with Order No. C19-12c at the workplace when interacting with the public, when working in or walking through common areas, and in any room or enclosed area when other people are present.
